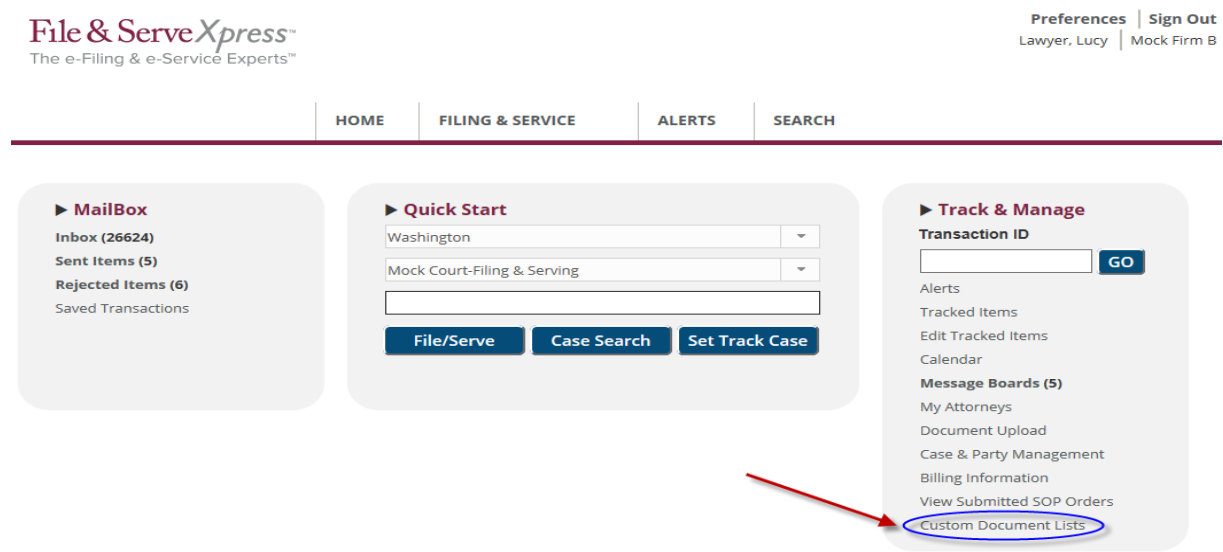

# Custom Document List Overview

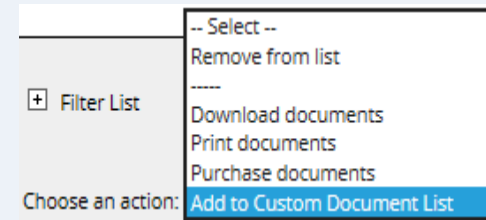
The **Custom Document List (CDL)** functionality allows File & ServeXpress Advanced users to create and manage lists of hand-picked documents that are available on the File & ServeXpress system. Users can name their **Custom Document Lists** and store detailed notes (both private and shared), in addition to storing their documents.

Users may also batch print or download from an existing **Custom Document List**. Once created, a **Custom Document List** is available to all users in the organization via their individual IDs using the **Custom Document List** link in the **Track & Manage** section of the File & ServeXpress **Home Page**. To **view** created Custom Document Lists, click the link the Track & Manage section of the File & ServeXpress Homepage.



## CDL Tips:

- ✓ **Functions (these actions can be performed on any screen where the user sees the “Chose an action” drop down):**
  - **Check Boxes.** Use the check box at the top of the column to select/de-select or “check” all of the boxes in the column to perform an action on. Use check boxes in individual rows to select/de-select individual records.
  - **Download documents.** Use to download multiple documents.\*
  - **Print documents.** Use to print multiple documents.\*
  - **Add to Custom Documents List.** Individually select documents to be stored in custom “folders”. Add the documents to existing or new folders and share notes. (See next page for more information on Custom Documents List).



- ✓ **Pricing:** There is no charge to use any of these features. Research charges will apply to all cases/documents on which the attorney is not attorney of record.

\*To use the Download Documents and Print Documents features, batch processing software must be downloaded<sup>4</sup>

## Creating Custom Document Lists

To add documents to a new **Custom Document List**:

1. Pull up the list of documents or transactions to be added and place a checkmark in the box to the left of the Transaction ID number or document title. To select all documents, choose the check box at the top of the column.
2. Select **“Add to Custom Document List”** in the Choose an action drop-down list at the top of the document list and click the **“Go”** button.

## CDL Tips:

- ✓ **Sample Use:** A firm clerk can create a **Custom Document List** to earmark the documents served on a client in numerous cases that an attorney needs to review. The clerk can pick documents from any case, specify the order in which the documents should appear to the attorney, and write a note to the attorney with special instructions. The attorney can then open the **Custom Document List**, read the clerk’s notes and documents contained in the list, and respond as necessary.
- ✓ Users may select individual documents or transactions from the following areas of the application:
  - Inbox Items (including Calendar events)
  - Sent Items
  - Rejected Items
  - Items for Clerk Review (for court users only)
  - Items for Judge Review (for court users only)
  - Case History Search
  - Daily Docket Search
  - Transaction Status Search
  - Advanced Search
  - Alerts
- ✓ **Note:** At this time, users cannot add documents to a Custom Document List from the Calendar search results page.

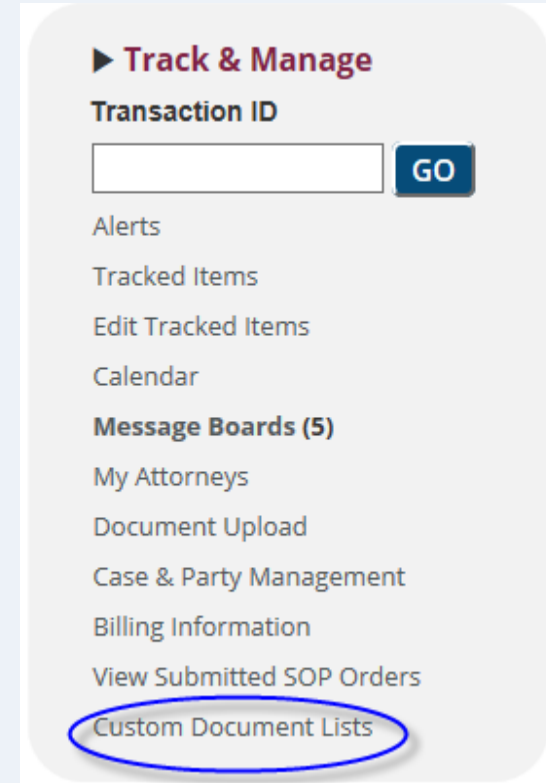

## Editing a Custom Document List

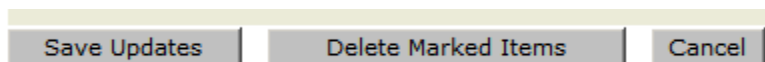
To **edit** an existing Custom Document List:

1. Click the **Custom Document Lists** link from the Track & Manage area on the Home Page. This will bring up a list where Users may edit existing Custom Document Lists:

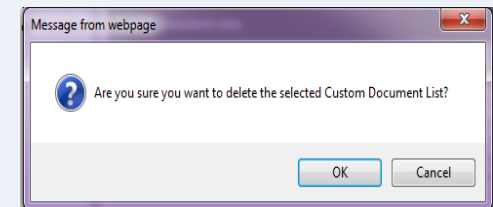
2. Click on the **Edit** link in the Edit Column to the right of the **Custom Document List** that should be accessed.
3. Use this screen to change the name of the Custom Document List, edit or remove notes, change the order of the documents, and remove specific documents.



4. When finished with any desired edits, click the "Save Updates" tab to save these changes to the system.

## CDL Tips:

- ✓ **Deleting a Custom Document List**  
After clicking the Delete link, a warning message confirms the delete action. When the user clicks "OK", the Custom Document List will be removed from the system. Clicking "Cancel" will return the user to the list of Custom Document Lists.



- ✓ **Note:** Once a Custom Document List has been deleted from the system, it cannot be accessed again.
